### **Advisory Committee for Students with Disabilities (ACSD)**

Meets the 2nd Wednesday of every month  
7pm, Gatehouse Administration Center, Room 1600

The ACSD is FCPS’ local special education advisory committee (SEAC). Virginia law requires that every school system have a SEAC to “advise the local school divisions of needs in the education of children with disabilities and participate in the development of priorities and strategies for meeting the identified needs of children with disabilities.”

Each monthly ACSD meeting includes agenda items such as updates from the Office of Special Education Instruction and the Parent Resource Center, and time for Public Comment. Meetings often include other presentations as well, such as those by Career & Transition Services in November. The sign up list for public comment is available near the sign-in sheet prior to the meeting start time.
